Please read these rules carefully, and don't hesitate to report any violations to ron@getagripchicago.com

- Members who are deemed to be unruly, disruptive or inappropriate in any way, will be suspended or removed as a member if you are asked to stop and continue with inappropriate behavior.
- Please do not post yours, or any other people's address, phone number or any other private information on our user forums or other online community blogs, live chat, singles classified, classified ads, etc.
- Any kind of obscene, profane, political, racist and hateful slurs will not be accepted, ever!
- Any profane, obscene or otherwise inappropriate username will be deleted or renamed.
- Any targeting or harassment of other members is not allowed at events, classes, etc. Please contact us immediately if this occurs. If any harassment continues while online, at events or during class times, we operate on a 3 strikes and you are out policy (verbal warning, written warning and no warning).. We will also contact the authorities on after removing any and all member or guests and prohibit them from coming around our members, events and classes.
- Please do not participate in any classes, events, etc. if you are intoxicated or under the influence of drugs. Your membership will be cancelled and the authorities will be notified.
- Please do not participate in any Getagripchicago activity if you have not consulted with your physician.
- Unauthorized advertising, soliciting or spamming is not allowed to any of our members or on our meet-up group.
- Betting and Gambling while participating in any Getagripchicago contests, challenge or league is prohibited.
- Soliciting our members or guests at events, in classes, etc., for business purposes is also prohibited.
- Getagripchicago does not sell member email names or allow or condone using email names as marketing tools
- Getagripchicago will not allow nude, obscene or offensive images in member profiles or name, or at public event or class. If you find any images, names, conversations – etc., to be in violation with our policies and high standard, please contact us ASAP.
- Getagripchicago intends to enforce a ZERO Tolerance policy for any offense above, and anyone caught cheating in contests, challenges or leagues will forfeit their ante and membership without a refund and be permanently banned as a member.
- All members of Getagripchicago must be at least 18 years of age. To participate in a Social activity in a bar or night club, you must show proof that you are over 21 years of age – no exceptions.

We reserve the right to apply penalties on a case by case basis for violation of any of these rules and guidelines. Any member who seriously violates these rules may be barred from the club and have their membership cancelled without a refund. These policies apply to our members, guests, employees, instructors, business partners and sponsors – all of whom are referred to in this agreement as MEMBERS.

Liability consideration for the use of the property, instructor or facility (i.e., Bash Sports Academy, Chicago Tennis and Golf, or any other "hosting facility) for GetaGripChicago and Bigcitygolfers Inc.

For participation in our classes, events, activities, the undersigned agrees as follows:

1. **Risk Factors-** The undersigned understands and acknowledges that the use of equipment and facilities provided by GetaGripChicago, Bash Sports Academy and it's affiliated programs and activities, and participation in any or all activities in the GetaGripChicago programs, involves risks, including, but not limited to the following: risk of property damage, bodily injury, including, but not limited to permanent disability, paralysis, and possibly death. These risks may result from the use of the equipment or facilities, from the activity itself, from the acts of others, or from the unavailability of emergency medical care.
2. **Assumption of Risk-** The undersigned voluntarily assumes all risks that may arise out of or result from the use of the equipment or facilities, and/or participation in the Getagripchicago events, classes and activities. including those risks described in Section 1 above. Exception being any injuries caused by the gross negligence or willful or wanton misconduct of any officials, officers, employees, agents, or volunteers of BigCityGolfers Inc. or GetaGripChicago (dba), Bash Sports Academy LLC, Chicago Tennis and Golf, and all other hosting facilities.
3. **Acknowledgement of Policies and Procedures-** The undersigned acknowledges reading and knowing all policies and procedures relating to the activities, facilities, and/or equipment and understands that the safe and proper use of facilities, equipment or participation in the activity is dependent upon carefully following such policies and procedures. The undersigned agrees to comply with and abide by all rules and regulations of the GetaGripChicago, Bash Sports Academy, Chicago Tennis and Golf and other hosting facilities (Business partner and or sponsor) reserve the right to revoke or terminate the undersigned's privileges for any violations of the rules and regulations of the Getagripchicago and it's hosting facilities for any violations of the policies and procedures relating to the activities, facilities, and/or equipment of the Getagripchicago or our hosting facility.
4. **Indemnify and Defend.** The undersigned hereby releases, waives, indemnifies and holds Getagripchicago, Bigcitygolfers Inc., Bash Sports Academy, Windy City Field house, Chicago Tennis and Golf, and all of their instructors, officers, trustees, directors, employees, and agents (hereinafter jointly referred to as "indemnitee") harmless from any and all claims, causes of action, suits, liability, losses, or damages for any property damage, property loss or theft, personal injury, death or other loss arising from or relating to the undersigned's use of the property, facilities, activities, classes and/or services of Getagripchicago and it's hosting facilities and network instructors.
5. **Prerequisite Skills.** The undersigned acknowledges that he or she has the requisite skills, qualifications, physical ability and training necessary to properly and safely use the equipment, facilities, and to participate in Getagripchicago Programs and activities, including dance, etc.. The undersigned agrees that if he or she has any questions as to what skills, qualifications, or training is necessary to properly use the equipment, facility, or participate in activities or classes from Getagripchicago itself, then he or she shall direct such questions to the appropriate Membership Representative or Instructor on site. The undersigned agrees that they have consulted with a doctor before enrolling in our classes.
6. **Waiver-** The undersigned waives the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise which the person giving the release does not know or suspect to exist at the time of executing the release. This means, in part, that the undersigned is releasing unknown future claims.
7. **Pay for damages.** The undersigned agrees to pay for any and all damages to any property or indemnitee caused by the undersigned negligently, willfully or otherwise.
8. **Representatives.** The undersigned enters into this agreement for him/herself, his/her heirs, assigns and legal representatives.
9. **Consent for Emergency Treatment-** The undersigned, as a participant in the subject activity, hereby consents to medical treatment in a medical emergency where the undersigned is unable to consent to such treatment.
10. **Insurance-** The undersigned understands that Getagripchicago does not carry participant insurance and that the undersigned will be solely responsible for any medical, health or personal injury costs relating to undersigned's use of the property, facilities and/or services of the Ray Meyer Fitness and Recreation Center. The undersigned is encouraged to have a medical physical examination and purchase health insurance prior to any and all participation.
11. **Jurisdiction.** This Assumption of Risk, Waiver, and Release from Liability Agreement shall be governed in all respects by the laws of the State of Illinois. The parties agree to use the State of Illinois for Jurisdiction and the County of Cook as Venue for any disputes between the parties.
12. **Severability.** If any term, clause, or provision of this Assumption of Risk, Waiver, and Release from Liability Agreement is held to be illegal, invalid or unenforceable, or the application thereof to any person or circumstance shall to any extent be illegal, invalid or unenforceable under present or future laws effective during the term hereof or of any provisions hereof which survive termination, then and in any such event, it is the express intention of the parties that the remainder of this Agreement, or the application of such term, clause or provision other than to those as to which it is held illegal, invalid or unenforceable, shall not be affected thereby, and each term, clause or provision of this Assumption of Risk, Waiver, and Release from Liability Agreement and the application thereof shall be legal, valid and enforceable to the fullest extent permitted by law.
13. **Acknowledgment-** The undersigned has read and fully understands this agreement and realizes it relates to surrendering and releasing valuable legal rights and does so freely and voluntarily.
